IV. HEALTH ATTESTATION

I, the undersigned official veterinarian, certify that:

1. The meat has been produced from sound and healthy animals clinically free from any disease;
2. The Netherlands is a BSE controlled risk country. In The Netherlands a monitoring on BSE takes place in accordance with OIE and EU legislation;
3. The meat or meat products described in this certificate were obtained from animals that not have been fed with processed animal protein mixed in fodder, with the exception of fish and dairy products;
4. Cattle from which the fresh meat and meat products destined for export were derived were not subjected to a stunning process prior to slaughter with a device injecting compressed air or gas into the cranial cavity or to a pitching process;
5. The fresh meat and meat products were produced and handled in a manner which ensures that such products do not contain and are not contaminated with:
 - a. the tissues listed in points 1 and 2 of Article 11.5.14., of OIE-Terrestrial Animal Health Code (20th edition);

- b mechanically separated meat from the skull and the vertebral column from cattle over 30 months of age;
 - 6. Cattle from which the fresh meat and meat products destined for export were derived are tested on BSE in accordance with OIE recommendations and EC legislation;
 - 7. The meat must be accompanied with Halal Slaughtering certificate issued from an Islamic Center.
 - 8. The meat or meat products described in this certificate were obtained under hygienic conditions and are considered to be fit for human consumption;
 - 9. The animals and the meat are subjected to a standard international system of meat inspection and hygiene in slaughtering and cutting establishments;
 - 10. Fresh meat and meat products destined to export to Oman originate from cattle reared in farms that are under supervision of the Competent Authority of the exporting country;
 - 11. The meat and meat products must be derived from animals slaughtered in a slaughterhouse and processed plants under permanent supervision of the Competent Authority of the exporting country;
 - 12. The consignment has been transported, in a vehicle which was cleansed and disinfected before the consignment has been loaded, directly from the approved establishment of origin to the point of departure without coming into contact with other products which do not fulfill the required conditions for export;
 - 13. The consignment of meat and meat products comes from animals which have been subjected to ante-mortem post mortem inspections in accordance with EC legislation;
 - 14. Fresh meat and meat products destined to export to Oman originate from cattle reared in farms with no BSE record for the last 7 consecutive years.
 - 15. Based on the result of the national surveillance program on harmful substances in accordance with Council Directive 96/23/EC the meat does not contain residue of such substances including hormones, antibiotics, pesticides and heavy metals in quantities hazardous to human health;
 - 16. The wrapping and/or packing of the meat or products bear a non-modifiable mark showing their plant(s) of production and the country of origin;
 - 17. The animals were slaughtered and the products were packed, stored and transported to the shipping port, without coming in contact whatsoever with pigs and pig products during above procedures.
